- Develop policies and procedures for the 2018 PIR and preparing for Federal On-Site Review monitoring and how to meet new compliance area questions

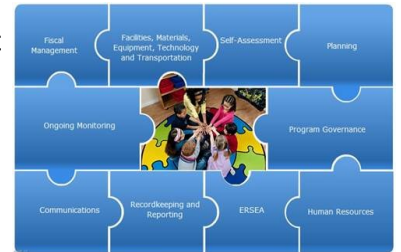

Participants will learn about the Aligned Monitoring 2.0 systems. This conference will also focus on the 2018 ERSEA PIR incorporating how to incorporate ERSEA standards and the Head Start management systems that are critical to sound ERSEA policies and procedures. Eligibility, Recruitment, Selection, Enrollment & Attendance

The conference's main objective is helping you to develop policies and procedures for ERSEA. Participants will learn specific strategies to monitor ERSEA standards, and determine how well their program meets Federal compliance and 2018 PIR reporting. The critical areas to be addressed are:

- **Attendance**—Students will learn what monitoring requirements are needed in order to monitor attendance and how to address families whose children are repeatedly absent.
- **Eligibility**—Students will learn key requirements for verification of eligibility and enrolling children and pregnant women with the greatest need for Head Start services first.
- **Enrollment**—Students will acquires strategies and tools to ensure their program maintains funded enrollment and meets the 10% enrollment requirement for children with disabilities.

Upon completion, you will learn how to setup:

- ERSEA monitoring systems such as, i.e., application/intake reporting, PIR data integrity checks
- 2018 PIR reporting standards and benchmarks
- Disabilities compliance requirements and determining between the PIR vs. Performance Standards reporting

ERSEA managers, Teachers, Home Visitors, Family Service Workers, Health and Management staff will gain knowledge to improve ERSEA monitoring systems. 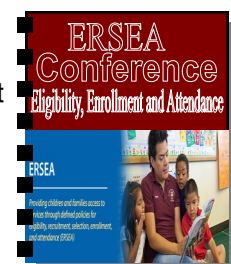
